NOTICE OF DIRECT PLANNING APPLICATION TO AN BORD PLEANÁLA IN  
RESPECT OF A STRATEGIC INFRASTRUCTURE DEVELOPMENT  
COUNTY OFFALY**

In accordance with section 37E of the Planning and Development Act 2000, as amended by the Planning and Development (Strategic Infrastructure) Act 2006, as amended by the Planning and Development (Amendment) Act 2010 and as amended by the Environmental (Miscellaneous Provisions) Act 2011, Green Wind Energy (Wexford) Ltd. gives notice of its intention to make an application for permission to An Bord Pleanála in relation to the following proposed development:

A fifteen-year planning permission for development of a 32 turbine wind farm, on a site, in the townlands of Deryarkin, Derryron, Coolcor, Coolville, Ballyburty, Greenhills, Bunsallagh, Derrygreenagh, Knockdrin, Wood, Killowen, Corbetstown, Carrick, Garr and Durville, just north of Rhode, Co. Offaly.

The development will comprise thirty-two (32) electricity generating wind turbines with a hub height of up to 110 metres and a rotor diameter of up to 113 metres and an overall height of up to 166 metres, hardstandings, a 110 kV substation containing two (2) control buildings, an electrical compound and a waste water holding tank, nine (9) watercourse crossings, a temporary construction compound, a permanent meteorological mast, a new access road off the R400 Roundabout at Rhode and upgraded access roads, associated site roads, drainage and site works.

The planning application, the Environmental Impact Statement and the Natura Impact Statement may be inspected free of charge or purchased on payment of a specified fee during public opening hours for a period of seven weeks commencing on December 4th 2013 at the following locations:

Submissions or observations may be made only to An Bord Pleanála ('the Board') 64 Marlborough Street, Dublin 1 during the above-mentioned period of seven weeks relating to -

(i) the implications of the proposed development for proper planning and sustainable development, and

(ii) the likely effects on the environment of the proposed development, if carried out.

(iii) the likely significant effects of the proposed development on a European site.  
Any submissions/observations must be accompanied by a fee of €50 (except for certain prescribed bodies) and must be received by the Board not later than 5.30p.m. on January 31st 2014. Please note that in accordance with section 251 of the Planning and Development Act 2000, the period beginning on 24th December and ending on 1st January, both dates inclusive, should be disregarded for the purposes of calculating the last date for lodgement of submissions or observations. Such submissions/observations must also include the following information:

- (i) the name of the person making the submission or observation, the name of the person acting on his or her behalf, if any, and the address to which any correspondence relating to the application should be sent,
- (ii) the subject matter of the submission or observation, and
- (iii) the reasons, considerations and arguments on which the submission or observation is based in full.

Any submissions or observations which do not comply with the above requirements cannot be considered by the Board.

The Board may in respect of an application for permission decide to -

- (a) (i) grant the permission, or
- (ii) make such modifications to the proposed development as it specifies in its decision and grant permission in respect of the proposed development as so modified, or
- (iii) grant permission in respect of part of the proposed development (with or without specified modifications of it of the foregoing kind),

and any of the above decisions may be subject to or without conditions,

or

(b) refuse to grant the permission.

XLIC maintains its company filings in Companies House in the United Kingdom under registered number 01884214 in accordance with Article 3(2) of Directive 68/151/EEC.

C. XLDS has no creditors.

The creditors of XLIC may exercise their rights in accordance with section 938 of the UK Companies Act 2006, which provides for a right of objection. On the formation of the proposed Societas Europaea, all rights and obligations of every creditor of XLIC shall be transferred, by operation of law, to the new Societas Europaea pursuant to Article 29 of Council Regulation (EC) No. 2157/2001.

D. XLDS does not have any minority shareholders. XLDS is wholly owned by XLIC and its nominees.

XLIC does not have any minority shareholders. The entire issued share capital of XLIC is held by XL Insurance (UK) Holdings Limited.
